

CONTEST RULES

The "Check Out the Homes for the Holidays Tour in Style!" Contest (the "Contest") begins November 1, 2017 at 9:00am Pacific Standard Time ("PST") and ends November 20, 2017 at 11:59pm PST (the "Contest Period").

1. ELIGIBILITY:

Contest is open to all legal residents of British Columbia who have reached the legal age of majority in their province/territory of residence at the time of entry, except employees, representatives or agents (and those with whom such persons are domiciled or directly related) of Kids Help Phone ("Sponsor"), or of Yellow Pages Homes Limited ("YP Next Home") (YP Next Home together with Sponsor, the "Contest Organizers"), their parent companies, subsidiaries, affiliates, prize suppliers, advertising/promotion agencies and any entity involved in the development, production, implementation, administration or fulfillment of the Contest (collectively, the "Contest Parties"). "Directly related" shall mean father, mother, brother, sister, children, wife, husband or common law partner if such employee, representative or agent of a Contest Party.

2. HOW TO ENTER:

Completing and Submitting Your Entry

To enter, go to www.westernliving.ca (the "Website") and follow the on-screen instructions to obtain the official contest entry form (the "Entry Form"). Fully complete the Entry Form with all required information, which requires you to: (i) enter your first and last name, complete mailing address (including postal code), valid email address and telephone number; (ii) sign up for *Western Living's* 3x weekly newsletter (required); (iii) signify your agreement that you have read and agree to be legally bound by the terms and conditions of these official rules and regulations (the "Rules"); and (iv) indicate whether you would like to receive additional information regarding upcoming events or promotions from the Contest Organizers (optional). Once you have fully completed the Entry Form with all required information, follow the on-screen instructions to submit your completed Entry (the "Entry"). To be eligible, your Entry must be submitted and received within the Contest Period. All eligible Entries submitted and received during the Contest Period will be entered into the random prize draw.

Entry Limitations and Restrictions

There is a limit of one (1) Entry per person and per email address permitted during the Contest Period. For greater certainty, you can only submit one (1) Entrant Material, using one (1) email address to enter the Contest. The sole determinant of time for the purposes of a valid Entry during the Contest Period will be the Contest's server machine(s).

Entry Verification and Entry Rejection

All Entries are subject to verification at any time and for any reason. The Contest Organizers reserve the right, in their sole and absolute discretion, to require proof of identity of entrant and/or eligibility of its Entry, including any Entrant Material (in a form acceptable to the Contest Organizers – including, without limitation, government issued photo identification) for the purposes of administering this Contest in accordance with these Rules. Failure to provide such proof to the satisfaction of the Contest Organizers in a timely manner may result in disqualification in the sole and absolute discretion of the Contest Organizers.

If it is discovered by the Contest Organizers (using any evidence or other information made available to or otherwise discovered by the Contest Organizers) that any person has attempted to: (i) obtain more than one (1) Entry during the Contest Period; (ii) use (or attempt to use) multiple names, identities, email addresses, accounts and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise

In the event of a dispute regarding who submitted an Entry, Entries will be deemed to have been submitted by the authorized account holder of the Account and/or, where applicable, the email address submitted at the time of entry. "Authorized account holder" is defined as the person who is assigned an email address by an internet provider, online service provider, or other organization (e.g. business, educational institute, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

The Released Parties (defined below) are not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries, all of which will be void and rejected. The Contest's Parties decision to disqualify an Entry or entrant shall be final without right of appeal.

3. PRIZES AND APPROXIMATE RETAIL VALUE:

There is **one (1)** prize available to be won. The prize consists of four Homes for the Holidays tour tickets* (\$50 per person) and chauffeured tour service by Star Limousine (\$150 per person) of \$800 CAN, for a total retail value of \$800 CAN (the "**Prize(s)**").

The Prize must be accepted as awarded and is not transferable, assignable or convertible to cash (except as may be specifically permitted by Contest Organizers in their sole and absolute discretion). No substitutions except at Contest Organizers option. Contest Organizers reserve the right, in their sole and absolute discretion, to substitute the Prize or a component thereof with a prize of equal or greater value, including, without limitation, but at Contest Organizers sole and absolute discretion, a cash award. Prize will only be awarded to the person whose verifiable full name and valid email address appears on the Account AND/OR the Entry Form associated with the Entry in question.

4. WINNER SELECTION:

On November 21, 2017 (the "**Draw Date**") at the offices of Yellow Pages Homes Limited., Burnaby, British Columbia at approximately 10:00am PST, one (1) eligible entrant will be selected by random computer generated draw from among all eligible Entries submitted and received during the Contest Period in accordance with these Rules. The odds of winning depend on the number of eligible Entries submitted and received during the Contest Period in accordance with these Rules.

The Contest Organizers or a designated representative will make a minimum of five (5) attempts to contact the selected entrant (using the information provided on the Entry Form) by e-mail or telephone, within seven (7) business days of the Draw Date. If the selected entrant cannot be contacted within seven (7) business days of the Draw Date, or if there is a return of any notification as undeliverable; then he/she may, in the sole and absolute discretion of the Contest Organizers, be disqualified (and, if disqualified, will forfeit all rights to the Prize) and the Contest Organizers reserve the right, in their sole and absolute discretion and time permitting, to randomly select an alternate eligible entrant from among the remaining eligible Entries (in which case the foregoing provisions of this section shall apply to such newly selected entrant).
